### Call It Out

In partnership with Jumbunna, we created an online register to record and report on racism and discrimination experienced by First Nations peoples.



### Partnership for Justice in Health

The P4JH is an alliance of academics, legal experts and First Nations groups addressing individual, institutional and systemic racism in health and justice systems.



### Hear Me Out

We have developed a ground-breaking AI-powered tool to help people find the right complaints pathways for their grievances.



### Alternative model for first responders

We are leading a national coalition and strategy to advocate for appropriate first responders, instead of police, to attend mental health crises.

## OUR LEGAL EXPERTISE

We work with clients who have experienced systemic discrimination and prejudice to seek and set precedents for institutional accountability through complaints, inquests and civil action. Our clients are First Nations individuals and communities, refugees and people seeking asylum, and people with disabilities.



### Immigration Detention

We are running cases seeking to establish legal precedent for the Government's duty of care to asylum seekers and refugees in offshore immigration detention.



### Healthcare

We examine whether discrimination is part of any mistreatment or negligence in healthcare settings, and highlight the importance of ethical and culturally safe practices to drive reform.



### Policing

We work to expose systemic discrimination and advocate for policing reforms to prevent mistreatment and abuse of people by police.



### Prisons

We defend the rights and dignity of incarcerated people and advocate for those harmed by abuses of power or the denial of access to quality healthcare.
